

REPRODUCTIVE MATERNAL NEWBORN AND CHILD HEALTH PRODUCT LIST



Improving reproductive, maternal, newborn and child health (RMNCH) has a direct positive impact on both the mother and her newborn child. It also strengthens families and communities.

As part of our commitment to improving maternal and child health, including antenatal care, nutrition, and immunisation, IDA is supplying products identified as having the potential to save the lives of women and children.

Many of these items have been in IDA's range for years, and it is critical that these high-impact products continue to receive extra attention.

Since 2021, IDA has supplied multiple micronutrient supplements (MMS), and heat-stable carbetocin (HSC)

as an addition to its portfolio:

- HSC (Ferring) can be used as an alternative to oxytocin after labour to help uterine contractions and thereby preventing the occurrence of post-partum hemorrhage (PPH). Unlike oxytocin, carbetocin has the advantage of not requiring cold chain storage and distribution.
- MMS (the standard for pregnant women in high-income countries) contain fifteen vitamins and minerals, including iron and folic acid. These support good health for mothers, improved birth outcomes, and better cognitive development and physical growth for unborn children. Access to MMS is particularly important for pregnant women in areas where a healthy diet is difficult to obtain.

FAMILY PLANNING RELATED PRODUCTS

Family planning enables women to space their pregnancies and delay childbearing, which is particularly important for younger women who are at an increased risk of complications. Despite the increase in contraceptive use over the past thirty years, many women in all regions still do not have access to modern products related to family planning, such as hormonal contraceptives, intrauterine devices (IUDs) and condoms (male and female).

MATERNAL AND CHILD NUTRITION

Malnutrition in pregnant women is a major public health challenge in low- and middle-income countries (LMICs). Poor diets lacking key nutrients such as iodine, iron, folate, calcium and zinc can cause health issues such as anaemia and pre-eclampsia in mothers, and stillbirth, low birth weight and developmental delays in children. Therefore, nutritious diets are essential before, during and after pregnancy, and while breastfeeding, to ensure the health of both mother and child. Proper nutrition is vital for children's physical and mental development.

Women and children must have access to nutritional products such as micronutrient and energy-protein supplements at different stages of life.

FEMALE HYGIENE PRODUCTS

Access to menstrual products is essential for improving menstrual health and hygiene. However, millions of women and adolescent girls worldwide cannot afford these products. IDA offers the Anandi sanitary pad, which was developed in India and is the country's first and only Government of India lab-certified (ISO 17088) sanitary pad that is almost 100% compostable and biodegradable.

OTHER RMNCH COMMODITIES

Breastfeeding provides good nutrition and plays an important role in food security and reducing inequalities by improving child development. IDA has added two breastfeeding-related products to its portfolio: a feeding cup to support newborns with breastfeeding difficulties and a manual breast pump to give mothers more flexibility in their breastfeeding routines.
